The labs are powered to acquaint students with state-of-the-art equipment such as 3D printers, robotics and electronics development tools, Internet of Things (IoT) and sensors etc. The Atal Innovation Mission has selected 5441 schools to establish Atal Tinkering Labs (and has sanctioned and transferred grant-in-aid of Rs. 12 Lac each to 1,109 schools) across the country.

As the world enters into the fourth industrial revolution, a new set of skills have to be developed and mastered. For India to contribute significantly to the fourth industrial revolution, we need to empower our youth with these 'skills of the future'. These skills include computational power, Internet of things (IoT), artificial intelligence, design thinking, advanced robotics, and cyberphysical systems – to name a few. The Atal Tinkering Lab is a platform for school students to develop these 'skills of the future' through practical application based on self-learning.
