VACANCY CIRCULAR

<u>Subject</u>: Filling up of two posts of Despatch Rider on Deputation/Absorption/Re-employment basis in NITI Aayog- reg.

It is proposed to fill up two vacant posts of Despatch Rider in NITI Aayog in Level-2 (Rs. 19,900-63,200/-) of the Pay Matrix on Deputation/Absorption/Re-employment basis as under:-

Deputation/Absorption:

Regular Despatch Riders/Group C employees from Ministries of the Central Government who possess the qualifications and experience prescribed as per Para-2 below.

For Ex-Servicemen:

Deputation/re-employment:

The Armed Forces Personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed as per Para-2 below, shall also be considered, and such persons shall be given deputation terms upto the date on which they are due for release from the Armed Forces and thereafter they may be continued on re-employment.

Note: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed three years.

2. The applicants must possess the educational qualifications and experience as prescribed under:

Essential:

- a) Pass in 10th class from a recognised Board.
- b) Possessing a valid driving license for Motor Cycle or Autorickshaw.
- c) Two years' experience in driving Motor-cycle or Autorickshaw.
- d) Knowledge of Motor Cycle or Autorickshaw mechanism (The candidate should be able to remove minor defects from the vehicle).
- e) Ability to read English and Hindi.

Desirable:

Three years' service as Home Guard or Civil Volunteers.

Note: The qualification regarding experience is relaxable at the discretion of the Competent Authority in the case of candidates belonging to the Scheduled Castes or Scheduled Tribes if at any stage of selection the Competent Authority is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancy reserved for them.

- 3. It is requested to forward the applications of interested & eligible employees in the enclosed proforma through proper channel so as to reach the undersigned within 60 days from the date of issue of this circular. While forwarding the applications, it may please be ensured that the particulars of the candidates are verified. The applications must be forwarded along with the following documents:-
 - (i) Proof of Educational qualifications and experience as per Para-2 above.
 - (ii) Original/attested photocopies of the APARs for the last 5 years;
 - (iii) Vigilance clearance certificate;
 - (iv) Integrity Certificate;
 - (v) No Major/Minor penalty certificate for last 10 years.
- 4. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently. Application received without aforesaid documents or after prescribed date, shall be rejected.
