### VACANCY CIRCULAR

## Subject: Filling up of one post of Staff Car Driver (Ordinary Grade) on Deputation/ Absorption/ Re-employment basis in NITI Aayog – regarding.

It is proposed to fill up one post of Staff Car Driver (Ordinary Grade) in NITI Aayog in Level-2 (Rs. 19,900-63,200/-) of the Pay Matrix on Deputation/ Absorption/ Reemployment basis as under:-

#### **Deputation/ Absorption:**

Regular Despatch Rider or Group 'C' employees in Level-1 (Rs. 18000-56900/-) in Pay Matrix in Ministries of the Central Government who possess valid Driving License for Motor Cars on the basis of a Driving Test to assess the competence to drive Motor Cars and who fulfill the necessary qualifications as mentioned in para-2 below.

#### Deputation/ re-employment for Armed Forces Personnel:

The Armed Forces Personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed in para-2 below shall also be considered. Such persons would be given deputation terms upto the date on which they are due to release from the Armed Forces; thereafter they may be continued on re-employment.

**Note 1:** The period of deputation including the period of deputation in another excadre post held immediately preceding this appointment in the same or some other organization/ Department of the Central Government shall ordinarily not exceed three years.

**Note 2:** The maximum age limit for appointment by deputation/ absorption shall be 'Not exceeding 56 years' as on the closing date of receipt of applications.

The applicants must possess the educational qualifications and experience as prescribed under:

#### **Essential:**

- a) Possession of a valid driving license for motor cars;
- b) Knowledge of motor mechanism (The candidate should be able to remove minor defects in vehicle);
- c) Experience of driving a motor car for at least three years; and
- d) Pass in 10<sup>th</sup> standard.

### Desirable:

Three years' service as Home Guard/ Civil Volunteers.

**Note 1:** The qualification regarding experience is relaxable at the discretion of the competent authority.

**Note 2:** In the case of candidates belonging to the Scheduled Castes or Scheduled Tribes if at any stage of selection, the competent authority is of the opinion that the sufficient numbers of candidates with requisite experience are not likely to be available to fill up the vacancy reserved for them.
