



01. India Social Development Report 2023 by Council for Social Development



This report highlights that gender inequalities and women's subordination in India are caused by two formidable macro-structures: patriarchy and the exclusion of unpaid work from the macro-economy. Both these structures reinforce each other and negatively impact women's empowerment. Patriarchy imposes subordination on women and forces a disproportionately higher share of unpaid domestic services and unpaid care onto them. This is unfair and unjust - a violation of basic human rights. Other structures like race, religion, and caste cut across these main structures. The selected papers in this report show how patriarchy causes gender inequalities in all critical dimensions of women's life on the one hand, and how unpaid domestic services and unpaid care sustains the macro-economy and its growth on the other. The contributors discuss pathways to integrate unpaid work with the macro-economy such that the strength of patriarchy declines and at the same time gender equality is promoted. To put it differently, unless the structures are addressed by integrating unpaid work, inequalities cannot be addressed effectively. The report emphasizes that this is the only way to move to real macroeconomics. The papers have explored pathways to break these structures gradually to achieve gender equality and empower women. Though the path is challenging, it is feasible to reach the goal of pervasive gender equality.







05. <u>The Dravidian Model: Interpreting the Political Economy of Tamil Nadu</u> by Kalaiyarasan A.




This book adds to the growing literature on dynamics of regional development in the global South by mapping the politics and processes contributing to the distinct developmental trajectory of Tamil Nadu, southern India. Using a novel interpretive framework and drawing upon fresh data and literature, it seeks to explain the social and economic development of the state in terms of populist mobilization against caste-based inequalities. Dominant policy narratives on inclusive growth assume a sequential logic whereby returns to growth are used to invest in socially inclusive policies. By focusing more on redistribution of access to opportunities in the modern economy, Tamil Nadu has sustained a relatively more inclusive and dynamic growth process. Democratization of economic opportunities has made such broad-based growth possible even as interventions in social sectors reinforce the former. The book thus also speaks to the nascent literature on the relationship between the logic of modernization and status based inequalities in the global South.

06. <u>Debt Sustainability of Subnational Governments in India: Lessons from</u> International Debt Crises by Hari Krishna Dwivedi




In 2020, for the first time in history, the world's debt as a percentage of its gross domestic product exceeded 100%. Although it has come down slightly since then, there are concerns about where the next debt crisis will happen, given that Pakistan and Sri Lanka have already found themselves in debt crises. India's overall fiscal health and macro-economic conditions remain stable, but the same may not be completely true when the discussion shifts to India's subnational entities. In Debt Sustainability of Subnational Governments in India: Lessons from International Debt Crises, Dwivedi attempts to answer this question by analysing the debt sustainability of the states in the context of many emerging issues and challenges to their fiscal health with the aim of providing usable and practical recommendations that can ensure the fiscal health of the subnational governments in India and across the world. Focusing on the state or provincial governments, Dwivedi addresses the debt that the government undertakes to fund its programmes and examines whether such governments are indulging in taking excessive debt. Some of the aspects covered in the book include international experiences with excessive borrowings or debt creation and the learnings from these experiences, trends of state government debt (subnational debt), emerging issues that pose challenges to state finances, and recommendations to control debt from spiralling out of control.

07. Institutional Roots of India's Security Policy by Milan Vaishnav




In recent years, India has asserted its desire not simply to be a 'balancing power', but to become a 'leading power' on the world stage. As India's economic development has steadily progressed, so too have its foreign policy and security ambitions. However, India's ability to sustain high rates of economic growth at home and project power abroad rest on unsteady and uneven state capacities. The goal of this book is to unpack and interrogate the governance of India's security institutions. Myriad inadequacies related to both procedure and personnel continue to hamper the Indian state's ability to perform one of its most essential functions: protecting Indians from security threats at home and abroad. Despite widespread concern over the severe capability constraints India's institutions face on a daily basis, there is little scholarly work studying the present administrative and organizational effectiveness of India's security institutions. This volume aims to remedy that by offering high-quality analytic narratives of nearly a dozen key national security institutions spread across four domains: the armed services, intelligence, border and internal security, and police and investigation.

08. Elections, Parties, and Coalitions in India by Eswaran Sridharan



It presents the evolution of key elections and shifts in voting patterns in the post-Congress-dominance period since 1989, showing how these have led to the rise or decline of parties; to a reshaped party system; and to particular patterns of coalition politics and types of coalition and/or minority governments. The book also shows how coalition politics has enabled the rise of the Bharatiya Janata Party and regional parties, enabled a revival of the Congress from 2004 to 2014, and affected elections and the party system in reverse. All the papers in this book undertake empirical analysis of elections and the party system – including origins, key elections, party behaviour, coalition patterns, and political finance – and are situated within the relevant theoretical and comparative literature. This collection makes interconnected historical, conceptual, theoretical, and empirical arguments in relation to Indian politics. It helps us make sense of the evolution of the post-1989 party system and is indispensable for scholars and students of Indian politics.

09. Burn Anger Before Anger Burns You by J P Vaswani



Getting to grips with the overlapping geopolitical, economic, and political crises faced by Western democratic societies in the 2020s.


