

#### 1. The Hindi Heartland: A Study by Ghazala Wahab




"The Hindi heartland, comprising Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Rajasthan, Uttarakhand, and Uttar Pradesh, covers nearly 38 per cent of India's total area and is home to over 40 per cent of India's population. It provides the country with over 40 per cent of its parliamentarians and determines the contours of national politics (out of the fifteen prime ministers India has had since 1947, eight have been from the Hindi belt). Yet, despite its political significance, the Hindi belt is among the most impoverished regions in the country. It consumes the bulk of the country's resources, but lags behind other states on various economic and welfare indices. It is plagued by violence, illiteracy, unemployment, corruption, poor life expectancy, and numerous other ills.

Centuries of war, conquests, invasions, political movements, and religious unrest have made the heartland a place of immense paradox. Despite its extraordinary and timeless religious heritage—some of the country's most revered spiritual leaders were born here and it is home to innumerable shrines and places of pilgrimage—it has also witnessed some of the worst communal riots in the country and has been troubled by long-running, divisive sectarian politics. Many of India's founders, who gave the country its secular identity, hailed from the heartland, but so too did those who have spread religious discord. And the land of Ganga–Jamuni Tehzeeb routinely witnesses lynching and murder in the name of religion........

This is the fourth, revised and updated, edition of Geoffrey Till's Sea power: A Guide for the Twenty-first Century.


The rise of the Chinese and other Asian navies, worsening quarrels over maritime jurisdiction and the United States' maritime pivot towards the Asia-Pacific region reminds us that the sea has always been central to human development as a source of resources, and as a means of transportation, informationexchange and strategic dominion. It has provided the basis for mankind's prosperity and security, and this is even more true in the early twenty-first century, with the emergence of an increasingly globalized world trading system. Navies have always provided a way of policing, and sometimes exploiting, the system. In contemporary conditions, navies, and other forms of maritime power, are having to adapt, in order to exert the maximum power ashore in the company of others and to expand the range of their interests, activities and responsibilities. While these new tasks are developing fast, traditional ones still predominate. Deterrence remains the first duty of today's navies, backed up by the need to 'fight and win' if necessary. How navies and their states balance these two imperatives will tell us a great deal about our future in this increasingly maritime century. This book investigates the consequences of all this for the developing nature, composition and functions of all the world's significant navies, and provides a guide for anyone interested in the changing and crucial role of sea power in the twenty-first century. Sea power is essential reading for all students of naval power, maritime security and naval history, and

highly recommended for students of strategic studies, international security and international relations.

# 3. Encountering Development: The Making and Unmaking of the Third World by Arturo Escobar




How did the industrialized nations of North America and Europe come to be seen as the appropriate models for post-World War II societies in Asia, Africa, and Latin America? How did the postwar discourse on development actually create the so-called Third World? And what will happen when development ideology collapses? To answer these questions, Arturo Escobar shows how development policies became mechanisms of control that were just as pervasive and effective as their colonial counterparts. The development apparatus generated categories powerful enough to shape the thinking even of its occasional critics while poverty and hunger became widespread. "Development" was not even partially "deconstructed" until the 1980s, when new tools for analyzing the representation of social reality were applied to specific "Third World" cases. Here Escobar deploys these new techniques in a provocative analysis of development discourse and practice in general, concluding with a discussion of alternative visions for a post development era. Escobar emphasizes the role of economists in development discourse--his case study of Colombia demonstrates that the economization of food resulted in ambitious plans, and more hunger. To depict the production of knowledge and power in other development fields, the author shows how peasants, women, and nature became objects of knowledge and targets of power under the "gaze of experts. "In a substantial new introduction, Escobar reviews debates on globalization and post development since the book's original publication in 1995 and argues that the concept of post development needs to be redefined to meet today's significantly new conditions. He then calls for the development of a field of "pluriversal studies," which he illustrates with examples from recent Latin American movements.

#### 4. Trade Wars are Class Wars by Matthew C Klein



A provocative look at how today's trade conflicts are caused by governments promoting the interests of elites at the expense of workers Trade disputes are usually understood as conflicts between countries with competing national interests, but as Matthew C. Klein and Michael Pettis show, they are often the unexpected result of domestic political choices to serve the interests of the rich at the expense of workers and ordinary retirees. Klein and Pettis trace the origins of today's trade wars to decisions made by politicians and business leaders in China, Europe, and the United States over the past thirty years. Across the world, the rich have prospered while workers can no longer afford to buy what they produce, have lost their jobs, or have been forced into higher levels of debt. In this thought-provoking challenge to mainstream views, the authors provide a cohesive narrative that shows how the class wars of rising inequality are a threat to the global economy and international peace-and what we can do about it.

### 5. Maritime Spatial Planning: Past, Present, Future by Jacek Zaucha





### 6. The AI-Centered Enterprise by Ram Bala



#### 7. India's Growth Narrative Performance and Potential by D.K. Srivastava




Dividing India's growth experience into distinct phases, *India's Growth Narrative: Performance and Potential (1951-52 to 2050-51)* argues that the lowest average growth of 3.5% during the late 60s and early 70s, which has often mistakenly been referred to as the 'Hindu Growth Rate' belongs to a socialist pattern phase of growth which was preceded by a colonial legacy phase. Subsequently, the Indian economy transitioned from a mixed economy phase to first reform, accelerating growth and global crises phases. Prospectively, India is projected to reach a stable growth of about 7.0%, which is more appropriately referred to as the 'Hindu Growth Rate' as it is consistent with saving and investment rates prescribed in India's ancient texts. After providing a phase-wise overview of the evolution of fiscal, monetary, financial and external sector policies, this book projects India's growth up to 2050-51. It shows how, within 100 years of the inception of the Constitution, India is slated to regain its past economic glory, reaching a Viksit status in a modern global economy.

#### 8. Northeast India: A Political History by Samrat Choudhury




A journalist's history of the short yet troubled life of this 'new' region bordering China and Southeast Asia, exploring its significance for the idea of India.

As India and the world are roiled by questions of nationalism and identity, this book journeys into the history of one of the world's newest and most fascinating regions: Northeast India. Having appeared with the stroke of a pen in 1947, as the British Raj was torn asunder and partitioned into India and Pakistan, this is a region of river valleys and hills inhabited by myriad tribes. Until colonial rule, several of these tribes had lived in their ancient ways, largely unmolested by their neighbors, who were rather keen to avoid their traditions of headhunting. Samrat Choudhury chronicles the processes by which these remote hill tribes, and the diverse other people's inhabiting the valley of the vast Brahmaputra River, became parts of the 'imagined nation' that is India. He explores two other ideas of India that remain in daily competition: Bharat, the Hindu nationalist conception of the country, and Hindustan, the Persian-origin name by which India is still known as far west as Turkey. Taking a long view, this absorbing political history chronicles the separate pathways by which imperialism, Christianity and the British love of tea brought each of the contemporary region's constituent states into modern India.

### 9. Bureaucrazy gets Crazier: IAS Unmasked by M.K. Kaw


