

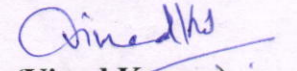

It is proposed to fill up one post of Assistant Manager-cum-Storekeeper in NITI Aayog in Level-4 (Rs.25,500 - 81,100/-) of the Pay Matrix on Deputation basis from amongst the Officers of the Central Government as under:

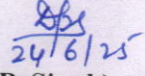
- a) (i) holding analogous posts on regular basis; or
- (ii) with eight years regular service in the level-2 in pay matrix (Rs. 19,900-63,200); and
- (iii) possessing the educational qualifications as below:
 - (I) B.Com from a recognised university; or
 - (II) Bachelor Degree in any discipline from recognised university with one year Diploma in Book keeping/ Store keeping; and
- (iv) three years' experience in handling Stores or Accounts in a Government Department or undertaking.

Note 1: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government shall ordinarily not exceed three years. The maximum age-limit for deputation is 56 years as on the closing date of receipt of applications.
